


HAZELNUT PRODUCTION IN TURKEY (in shell, 1.000 ton)

WORLD HAZELNUT PRODUCTION (in shell, 1.000 ton)




SHARE OF TURKISH HAZELNUT PRODUCTION IN THE WORLD (%)





TURKEY'S AVERAGE MONTHLY EXPORT PRICES FOR STANDARD SHELLED








TURKEY'S HAZELNUT EXPORT MARKETS (01.09.2014-31.08.2015)

EU's Official Controls on Hazelnuts





Problems encountered by Turkish exporters of hazelnuts at Kapitan Andreevo (Bulgaria)

Frequency of controls at Kapitan Andreevo is higher than random level

• Request of conducting controls at random level

Duration of official controls at Kapitan Andreevo causes disruption of trade

Request of completion of official controls at a shorter time

Compulsory controls (physical and identity checks) at Kapitan Andreevo

 Art. 9 par. 5 of 884/2014/EU indicates designated points of import (DPI) for those checks

Damaged packages during sampling at Kapitan Andreevo

250 Euro loading/unloading fee for each lot



Problems encountered by Turkish exporters of hazelnuts at Kapitan Andreevo (Bulgaria)

SPS Working Group, March 2015

- Frequency of physical controls higher than random level
- 250 Euro loading/unloading fee for each lot
- COM reply:
 - BG phytosanitary checks are in conformity with EU legislation in DG SANTE domain
 - will inform Turkey of BG's reply to Commission letter dated 26.03.2015 on this issue
- 47th EU/Turkey Customs Co-operation Committee, March 2015
 - Frequency of physical controls higher than random level
 - compulsory controls at Kapitan Andreevo
 - damaged packages during sampling
 - 250 Euro loading/unloading fee for each lot
 - COM reply:
 - commitment to raise the matter with the Bulgarian authorities after having received the relevant documents





Problems encountered by Turkish exporters of hazelnuts at Kapitan Andreevo (Bulgaria)

We sent a letter to DG TAXUD with relevant documents, April 2015

DG TAXUD replied, investigating the issue both internally and with the Bulgarian authorities, April 2015


32nd EC-Turkey Customs Union Joint Committee, April 2015

- Frequency of physical controls higher than random level
- damaged packages during sampling
- 250 Euro loading/unloading fee for each lot
- COM reply:
 - will inform Turkey after examining the letter from Turkish side and discussing the matter with the Bulgarian authorities
 - Damaged packages matter is in DG SANTE domain



Official Controls

Official Controls at Entry into EU



«All official controls before the completion of the CED shall be performed within <u>15 working days</u> from the moment the consignment is offered for import and physically available for sampling at the DPI.»

Risk of moisture at ports

Request of shortening 15 working days



Delisting of hazelnuts from Annex 1 of Commission Implementing Regulation (EU) 884/2014

- Aflatoxin controls on hazelnuts imports from Turkey started in 2002
- Frequeny of controls: 5% in 2006, 10% in 2010, 5% in 2012, random in 2014

Turkish Hazelnut:

- 2012 FVO Mission Results (Controls of Aflatoxin Contamination):
- Farmers' training on implementation of Good Agricultural Practices
- Risk-based inspections of processors, wholesalers, retailers, importers and exporters of food
- Reinforced controls at all stages to prevent aflatoxin contamination in hazelnuts
- HACCP principles
- High-quality, High-tech facilities



Information on aflatoxin controls on hazelnuts from Georgia and Azerbaijan

Between 2011-2015, Georgia has received 5 RASFF notifications Azerbaijan's has received 4 RASFF notifications

Georgia's exports to European Union is about 19.100 ton in 2013 and 15.000 ton in 2014

Azerbaijan's exports to European Union is about 4.000 ton in 2013 and 4.700 ton in 2014
